### QUALIFIED SHAREHOLDING

Within the terms of number 1 of article 17 of the Portuguese Securities Code, we hereby publicly disclose that yesterday Credit Suisse Securities (Europe) Limited, notified us of the following, by a letter dated November 30, 2007:

"Within the terms and for the purposes of numbers 1 and 2 b) of article 16 of the Portuguese Securities Code, and of article 2 of the CMVM Regulation 4/2004, we hereby inform that, by virtue of the Credit Suisse International's over the counter sale of 6,594,479 shares of CIMPOR – Cimentos de Portugal, SGPS, S.A. ("CIMPOR") on November 22, 2007, the investment banking area of Credit Suisse reduced its qualified shareholding to a lower than 2% percentage of the CIMPOR'S share capital and voting rights.

After the aforementioned sale, the following participations in CIMPOR's share capital are attributable to the companies belonging to the investment banking area of Credit Suisse as follows:

Credit Suisse International: 5,600,458 CIMPOR ordinary shares plus 2,837,259 CIMPOR shares borrowed to Credit Suisse Securities (Europe) Limited, correspondent to 1.26% of the share capital and voting rights of CIMPOR;

Credit Suisse Securities (Europe) Limited: 3,108,438 CIMPOR shares (including the 2,837,259 CIMPOR ordinary shares that have been borrowed by Credit Suisse International), correspondent to 0.46% of the share capital and voting rights of CIMPOR;

Credit Suisse Securities (USA) LLC: 165,010 CIMPOR ordinary shares, correspondent to 0.02% of the share capital and voting rights of CIMPOR.

Therefore, Credit Suisse investment banking division now holds a global participation of 8,873,906 CIMPOR ordinary shares, which corresponds to 1.32% of the share capital and voting rights of CIMPOR.

Credit Suisse International, Credit Suisse Securities (Europe) Limited and Credit Suisse Securities (USA) LLC are integrant companies of the investment banking area of Credit Suisse. Credit Suisse International is directly controlled by Credit Suisse (International) Holding AG, Credit Suisse Securities (Europe) Limited is directly controlled by Credit Suisse Investment Holdings (UK) and Credit Suisse Securities (USA) LLC is directly controlled by Credit Suisse Securities (USA) Inc., while these dominant companies are controlled by the Credit Suisse Group."
