QUALIFIED SHAREHOLDING

Within the terms of number 1 of article 17 of the Portuguese Securities Code, we hereby publicly disclose that Financière Lafarge notified us of the following, by fax dated August 2, 2007:

“For the purposes of the applicable legislation, notably article 16 of the *Código dos Valores Mobiliários*, Financière Lafarge SAS, a limited liability company incorporated under the laws of France, with head offices at 61, rue des Belles Feuilles, Paris, (“Financière Lafarge”), hereby notifies each of the entities to whom this notification is addressed that, on the present date and following the execution of several stock trades carried out outside of the Official Quotations Market of the Euronext Lisbon, on August 1, is owner of 31,075,000 shares of Cimpor – Cimentos de Portugal, SGPS, S.A. (“Cimpor”), representing 4.624% of the share capital and 4.638% of the voting rights.

Due to the existence of a control relationship with Financière Lafarge, the abovementioned percentages of share capital and voting rights are also allocated to the following entities: Lafarge SA, a limited liability company incorporated under the laws of France, with head offices at 61, rue des Belles Feuilles, Paris, (“Lafarge”) and Société Financière Immobilière et Mobilière SAS, a limited liability company incorporated under the laws of France, with head offices at 61, rue des Belles Feuilles, Paris (“Sofimo”).

Since Lafarge and Sofimo are also allocated with the percentages of share capital and voting rights related with the holding in Cimpor owned by Ladelis, SGPS, Lda., with head offices at Avenida da Liberdade, 200, 4º Esq., Lisboa, involving 84,907,705 shares and representing 12.635% of the share capital and 12.673% of the voting rights, the total percentages of share capital and voting rights allocated to such entities amount, respectively, to 17.259% and 17.311%.

The percentages of share capital and voting rights were calculated on the assumptions that the share capital of Cimpor, in the amount of €672,000,000.00, is represented by 672,000,000 registered and dematerialised shares, with a nominal value of €1,00 each, all of them listed to trading on the Official Quotations Market of Euronext Lisbon, and that Cimpor, based on the communication the same made on 14 March 2007, holds 2,029,510 own shares, representing 0.302% of its share capital.”

We also inform that CIMPOR – Cimentos de Portugal, SGPS, S.A., currently holds 2,097,092 own shares and therefore the above mentioned participations of Financière Lafarge, Ladelis and Lafarge/Sofimo correspond today to 4.639%, 12.675% and 17.313%, respectively, of the voting rights in this company.
